First presented in 2008 (when just 13 charities received the award), the number of organizations qualifying for this award has dramatically increased since we started it! You may apply for this award even if your board has received recognition in the past!

Be sure we have your nomination form by November 3, 2017. Charities with 100% board giving will be recognized in print, online, with a certificate, and at the 2016 Association of Fundraising Professionals' Cornerstone Luncheon, held in November (attendance is not mandatory to receive this award).
