- The TMs and PUDs listed in the table above are only those with units remaining to be built. Thus this table does not account for all development within the past year. For example, of the ca. 323 MF units built since March 2016 only 21 reside within the PUDs/TMs listed above. In 2016, 220 MF units were built in the Fountainhouse TM alone which is not listed above since zero (or very few) units remain to be built in that project.
